Requirements:

Candidates must possess:

- i. MBBS degree or its equivalent from a recognized University.
- ii. Evidence of full registration with the Medical and Dental Council of Nigeria (MDCN).
- iii. NYSC discharge certificate or evidence of exemption.
- iv. Fellowship of the West Africa College of Physicians/Surgeons or National Postgraduate Medical College of Nigeria or its equivalent in the specialty.
- v. Current Practicing License.

2. Post – Registrar: CONMESS 03 (General Surgery, Family Medicine, Community Medicine, Paediatrics, O&G, Anesthesia, Mental Health, Ophthalmology, Internal Medicine, ENT)

Requirements:

Candidates must possess:

- i. MBBS degree or its equivalent from a recognized University.
- ii. Evidence of full registration with the Medical and Dental Council of Nigeria (MDCN).
- iii. NYSC discharge certificate or evidence of exemption.
- iv. Current Practicing License.
- v. A pass in the Primary Examination in either National PMCN or West Africa College of Surgeons/Physicians in the relevant field.

3. Post – Medical Officer: CONMESS 03

Requirements:

Candidates must possess:

- i. MBBS degree or its equivalent from a recognized University.
- ii. Evidence of full registration with the Medical and Dental Council of Nigeria (MDCN).
- iii. NYSC discharge certificate or evidence of exemption.
- iv. Current Practicing License.

4. Post – Nursing Officer: CONHESS 07/09

Requirements:

Candidates must possess:

- i. a. BNSc qualification plus evidences of NYSC certificate and Internship completion (SNO).
b. BNSc qualification plus evidence of NYSC certificate or Internship completion (NOI).
c. RN plus additional professional registration in any Post Basic Nursing programme (NOII).
- ii. Current Practicing Licence.

5. Post – Pharmacists: CONHESS 09

Requirements:

Candidates must possess:

- i. A degree in Pharmacy from a recognized University.
- ii. Must have registered with the Pharmacists Council of Nigeria.
- iii. NYSC discharge certificate or evidence of exemption certificate where applicable.
- iv. Current Practicing Licence.

6. Post – Radiographer/ Imaging Scientist: CONHESS 09

Requirements:

Candidates must possess:

- i. A degree in Radiography from a recognized University.
- ii. Must have registered with Radiographers Registration Board of Nigeria.
- iii. NYSC certificate.

- ii. Full registration with the Medical Rehabilitation Therapy Board (MRTB).
- iii. Full registration with the Speech and Audiology Association in Nigeria (SPAN).
- iv. NYSC Discharge Certificate or Exemption.

8. Post – Speech Therapist: CONHESS 07/09

Requirements:

Candidates must possess:

- i. Bachelor degree in Special Education (with specialization in Audiology/ Speech Therapy)/Bachelor degree in Audiology/ Speech Therapy or Master degree in Audiology/ Speech Therapy.
- ii. Full registration with the Medical Rehabilitation Therapy Board (MRTB).
- iii. Full registration with the Speech and Audiology Association in Nigeria (SPAN).

9. Post – Optometrist: CONHESS 09

Requirements:

Candidates must possess:

- i. Doctor of Optometry (OD) degree or equivalent.
- ii. Evidence of Registration with the Optometrists and Dispensing Opticians Board of Nigeria.
- iii. NYSC Discharge certificate or Exemption.
- iv. Current Practicing Licence.

10. Post – Medical Laboratory Scientist: CONHESS 09

Requirements:

Candidates must:

- i. A degree in Medical Laboratory Science from a recognized University
- ii. Must have registered with Medical Laboratory Council of Nigeria
- iii. NYSC discharge certificate or evidence of exemption certificate where applicable
- iv. Current Practicing Licence.

Requirements:

Candidates must possess certificate in Health Assistant Medical (HAM) from the two-year training programme in any approved and accredited College of Health Technology or any other approved Health Institution.
